**4. Concise Explanatory Statement - §42-35-2.6**

Rules and Regulations Regarding Eligibility for Pupil Transportation Certificate are necessary to ensure that the applicant's personal background and driving history demonstrate their ability to safely operate pupil transportation vehicles and interact with school children. These rules set forth in detail the application process to obtain a pupil transportation certificate, including a step by step review of the process and required documentation. These rules establish the minimum qualifications required to obtain a pupil transportation certificate. Furthermore, these rules specify which offenses on an applicant's driving record or criminal history would prevent the applicant from obtaining a pupil transportation certificate. Also included are discretionary criteria which, after a hearing, may prevent the applicant from obtaining a pupil transportation certificate.
