The meeting was called to order at 10:02 am by James Woloohojian.

A motion to accept the minutes of the previous meeting was made by James White and seconded by Ellery Wood. The motion passed unanimously by the Board.

Hearings:

1.) James F. Broyles (Viol # 4082): The hearing did not take place as the fine was paid prior to today's scheduled hearing.

2.) Marguerite Concrete, Inc (Viol # 4084): David Rodrigues, Chief Hoisting Investigator, and Jim Marguerite, Marguerite Concrete, Inc. are sworn in for testimony. James Woloohojian read the violation: Violation Date: 6/7/11, Violation # 4084, Marguerite Concrete, Inc. 11 Rosenfeld Dr., Hopedale, MA 01747. Location of the Violation was University of R.I., Hillside Residence Hall, Baird Hill Rd., South Kingstown, RI. Violation: On Friday, May 13, 2011, Mr. David M. Rodrigues, Chief Hoisting Engineer Investigator, witnessed James F. Broyles, an employee of Marguerite Concrete, Inc., 11 Rosenfeld Dr., Hopedale, MA 01747, operating a construction forklift without a valid RI Hoisting Engineer's License at the above location. According to RIGL 28-26-12 "Investigation and Prosecution of Violation", this is (1) one violation of RIGL 28-26-5 "License Required for Operation of Hoisting Machinery". David Rodrigues gives testimony. Jim Marguerite addressed the Board. The Board questions Mr. Marguerite. David Rodrigues addressed the Board. Mr. Marguerite addressed the Board. James White made a motion that violation 4084 did occur; seconded by Brian Iannuccillo and passed unanimously by the Board. Ellery Wood, Jr. made a motion to uphold the original fine of \$600.00; seconded by James White and passed unanimously by the Board.
