WORKFORCE INVESTMENT ACT TITLE I/WAGNER-PEYSER ACT

Notice is hereby given that the State Workforce Investment Office of the RI Department of Labor and Training is making available for public review and comment the documents associated with the Extension and Modification to the One-Year Title 1B WIA/ Wagner Peyser State Workforce Plan for the period July 1, 2009 through June 30, 2010.

The Governor's Workforce Board RI, legislated under the federal Workforce Investment Act (WIA) of 1998, administers workforce investment services for all Rhode Island cities and towns. The Plan describes the state's workforce investment strategies related to services for adults, dislocated workers, youth and employers and aligns the four primary goals within the *Strategic Workforce Plan for Rhode Island 2009-2014*.

As outlined in instructions issued April 15, 2010 in TEGL 21-09 from the U.S. Department of Labor (DOL), Rhode Island is selecting approval under Option I which extends the current State Plan for the period July 1, 2010 through June 30, 2011 or until subsequent guidance is issued due to WIA reauthorization. Written comments are welcomed and will be accepted within twenty (20) days of the date of publication of this notice. An oral hearing will be granted if requested by twenty-five (25) persons or a governmental subdivision or agency, or by an association having not less than twenty-five (25) members.
